

As NH+C’s new CEO, it brings valuable perspective to reflect on NH+C’s 2024 performance, and its strong legacy of stewardship and service to the community.

NH+C’s team of experienced and emerging leaders are continuing the momentum that has made NH+C a community fixture and regional destination for 120 years.

Some 2024 highlights:

- **648 births** (including 3 sets of twins)
- **Cancer Care** accreditation from the American College of Surgeons
- **14,102 Emergency Department** visits
- Record volumes for **Rehabilitation Services**

The year brought challenges too, including the Change Healthcare cyberattack that affected billing, payment, and insurance verification processes for hospitals and clinics across the U.S. (including NH+C). A national shortage of IV fluids was caused by hurricane damage to the production plant that was producing over 60% of IV solutions used by U.S. hospitals. And financial pressures continue to challenge hospitals’ stability. Our team will continue to rise to each challenge, to provide the best care possible to our communities.

The caliber of talent in NH+C’s clinical and leadership teams is impressive. Our team members are professional, welcoming, and knowledgeable. NH+C’s talented team continues to provide excellent care to our communities.

We’re proud to be an independent organization that advocates for patient choice and the best care for the individual. Through relationships with regional organizations such as Mayo Clinic, Hennepin Healthcare and Allina’s Minneapolis Heart Institute, we provide access to those systems when patients need it, while providing great care close to home.

## 2024 FINANCIAL HIGHLIGHTS

The organization continued see volume growth in almost all areas and departments. Many of these volumes have surpassed pre-pandemic levels as we continue to experience record levels in most areas.

With the increase in patient volumes and total revenue, NH+C saw increased pressure from insurance companies and realized less than 1% increase in net patient revenue. We cut back on unprofitable services in 2023 and as a part of rebasing efforts were able to decrease our expense profile by \$5 million. Inflationary pressures have eased but are still impactful in many categories including wages, supplies, and drugs. These factors contributed to improvement from 2023 to 2024 but still resulted in a negative operating margin for 2024. The healthcare industry will continue to face headwinds in 2025 and beyond, from federal and state policy, inflationary and expense pressures, and changes in the insurance landscape.





## New partnerships and services



NH+C partnered with **Tareen Dermatology** in June 2024, bringing dermatology services back to our Farmington Clinic with two providers:

**Dr. Scott Tuttle** is a board-certified dermatologist who specializes in medical and surgical dermatology. His medical degree is from University of Pennsylvania School of Medicine; he served as Chief Resident during his dermatology residency at Mayo Clinic.



**Hannah Petterson, PA-C** is a board-certified physician assistant specializing in medical and surgical dermatology. She holds a Master of Physician Assistant Studies from St. Catherine University.

Tareen Dermatology has 22 board-certified providers and six locations specializing in medical, surgical, and cosmetic dermatology.

**Podiatry services** began in September 2024 through a new partnership with Advanced Foot and Ankle. Three board-certified providers see patients in the Northfield and Lakeville clinics, with surgeries at Northfield Hospital. Services range from conservative care to advanced surgical treatments.

In July, Rehabilitation Services added **Pediatric Rehab Bowel and Bladder Dysfunction** care for kids over age 4, in Rehab Services' Northfield clinic.

In August, NH+C partnered with University of Minnesota for **Maternal Fetal Medicine**. UofM providers see patients in the Women's Health Center on the hospital campus.

## NH+C earns prestigious Cancer Care accreditation



**NH+C's Cancer Care team** earned top marks in 2024 from the Commission on Cancer, the rigorous accreditation process that distinguishes elite cancer care in the U.S.

This is formal recognition for the excellent cancer care we provide, from our Cancer Care & Infusion Center and Breast Care Center to our surgeons, imaging staff (plus lab, pathology, pharmacy, rehab therapists, dietitians, social workers) and Mayo Clinic partners for oncology and radiation oncology.

Commission on Cancer is led by the American College of Surgeons. It's gratifying to know that NH+C is bringing their high standard of care to our patients.

The multi-year process was led by CCIC Director **Jodi Wieczorek, APRN, AGCNS-BC, ACHPN, OCN** with a large team of dedicated staff and providers across the organization.


